- The General Index for the month of November 2018 is **0.5%** higher as compared to the level in the month of November 2017. The cumulative growth for the period April- November 2018 over the corresponding period of the previous year stands at **5.0%**.
- Textiles (excluding apparels) were down by (-) 4.8%, Wearing Apparel was up (+) 22.1% in November 2018 over the same month previous year.
- Cumulative change for April- November 2018 for textiles was up by (+) **2.5%** and wearing apparel was up by (+) 8.4% over the same period previous year.

Monthly Export Update on Textile & Clothing: (December 2018)

- India's textile and clothing exports were down by from US\$ 3,002 -0.3% mn. in December 2017 to US\$ 2,993 mn. in December 2018. However, all commodity exports of India were up by 10% in December 2018 over the same month of previous year. Also, the share of textile and clothing in India's total exports remained constant at 11% in the same period.
- Cumulative textile and clothing exports during April'18- December 2018 was to the tune of USD **26,174** mn. as against USD **26,142** mn. in April'17 December 2017 indicating an increase of 0.1%. During the April'18 December 2018 textile exports were up by 8% while clothing (excluding textiles) declined by -8%.
- During April'18 December 2018, the exports of two subsectors have registered negative growth as compared to April 17 December 2017:
 - o Apparel by 8%

- o Jute Mfg. including Floor Covering by 1%
- While export of other subsectors have increased:
- Cotton Yarn/fabric/made-ups, Handloom Products etc by 11%
- Man-made Yarn/fabric/made-ups etc. by 4%
- Handicrafts excl. handmade carpet by 0.9 %
- Carpets by 4%
